On 26 August 2016, our company was established and registered with the Philippines Securities and Exchange Commission primarily to be Udenna Corporation's – our parent company's shipping and logistics pillar.

Since incorporation, we have continuously expanded our fleet and reach through several strategic acquisitions of reputable local shipping lines and logistics brands. We view these deals as key steps towards fulfilling our vision of being your choice of the finest shipping and logistics company in the country.

Further, through employing a variety of mechanisms in improving our shipping and logistics competencies, we aim to (i) provide more job opportunities to Filipinos, (ii) fuel more economic growth as our vessels accommodate the growing imports, exports and domestic shipping requirements, and (iii) provide long-term value to our stakeholders.

We offer integrated shipping and logistics solutions nationwide through our major subsidiaries as follows:

- **Chelsea Shipping Corp. (CSC)** – Our tankers and tugs shipping arm, which primarily transports petroleum and other bulk liquid products.
- **Trans-Asia Shipping Lines, Incorporated (Trans-Asia)** – Our passenger and cargo shipping line with operations nationwide.
- **Worklink, Services, Inc. (WSI)** – Our logistics and forwarding arm, which provides reliable courier, trucking and warehousing services nationwide.
- **Starlite Ferries, Inc. (SFI)** – Our passenger and cargo shipping line with operations in the Luzon and Visayas regions.

We also own 28.15% indirect economic interest in 2Go Group, the largest supply chain enterprise and end-to-end solutions provider in the Philippines.



**WHERE WE ARE.**

From a single vessel in 2006, CLC has grown its fleet to a formidable 88 vessels, which include 30 roll-on/roll-off passenger vessels, 11 fastcrafts, 16 cargo ships, 12 tankers, 14 tugboats, 4 barges and a floating dock. CLC's current fleet can carry approximately 120 million liters of petroleum products, 6,000 TEUs of cargo, and 28,000 passengers at any given time. This fleet calls in all major ports in the Philippines.
