Chelsea Logistics and Infrastructure Holdings Corp. would like to clarify the news articles which appeared in various newspapers on October 4 , 2019 which read:

"DITO Telecommunity Corp. continues to prepare for its commercial launch by tapping the Singson-led LCS Group and ABS-CBN's broadband arm Sky Cable Corp. for the deployment of network infrastructure.

The new telco player, backed by Davao-based businessman Dennis Uy and China Telecommunications Corp., said on Thursday it signed a memorandum of agreement with the LCS Group, a losing third telco bidder led by former Ilocos Sur Gov. Luis 'Chavit' Singson, for the lease of common towers.

No details about the common tower deal were disclosed in the statement, including the number of cell sites to be built, as well as their locations, but Dito Chief Administrative Officer Adel Tamano said both parties would begin the groundbreaking in the 'next few days.'

The challenger to the PLDT-Globe duopoly also teamed up with Sky Cable Corp. for the utilization of the latter's unused fiber-optic cables in Metro Manila.

'These two deals allow Dito to tap reliable local partners and their existing telecommunication infrastructure assets to support our network rollout without having to build everything from scratch; done to ensure that we soon deliver on our promise of faster, more affordable, and most importantly, secure internet connectivity for our countrymen,' Tamano said in a statement.
